GENERAL INFORMATION AND INSTRUCTIONS

Signatures: Signatures of the eight members, including that of the Club's President, are required to verify that the Club satisfies the Federation rule that a Club must have a minimum of eight members in its first year in order to be affiliated. If the Club has more than eight members, only eight need *sign* but the names and addresses of the other members must also be provided in order to enroll them and issue membership cards. All of the membership data (names, addresses, photos etc.) is sent by e-mail. Please contact the Secretary Secretary@USAPetanque.org for instructions on how to proceed.

Provisional and Full Affiliation: The President of the Federation is authorized to extend provisional affiliation upon receipt of this application. Provisional affiliation gives the Club all the rights and privileges of full affiliation except for the right to vote for Officers and Counselors, a right which comes with full affiliation. Full affiliation is conferred by the Board of Directors, normally at its next meeting following provisional affiliation.

A club must increase membership to at least twelve members in its second and subsequent years in order to maintain its affiliation status by demonstrating an active and viable pétanque program.

Membership Cards: Membership cards in the Federation of Petanque★USA (FPUSA) will be made out for each club member. The cards will be sent to the Club President who must sign and distribute them to the members. These membership cards are recognized by other member federations of the FIPJP, the international governing-body of the sport of pétanque.

Signed Waivers of Liability: All our members are required to sign a "Waiver and Release" form common in all organized sports. No membership card can be sent until your signed waiver is on file with FPUSA. Please contact the FPUSA Secretary for the forms and further instructions on this.
